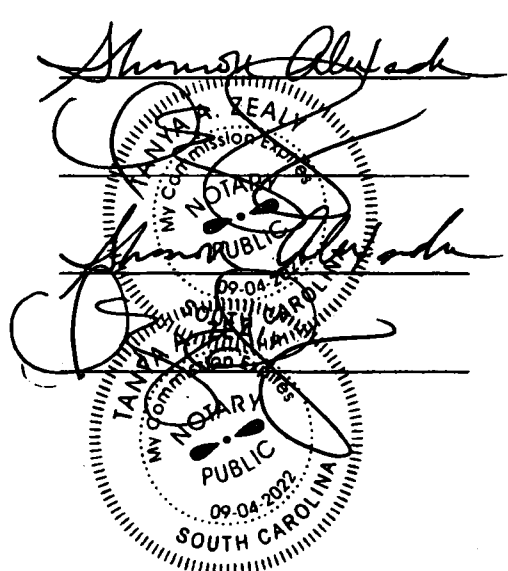
WHEREAS, the Master Deed was subsequently amended by Amendment to Master Deed recorded in Book Z-180, Page 187 ("First Amendment"), Amendment to Master Deed recorded in Book W-330, Page 643 ("Second Amendment"), 3rd Amendment to Master Deed recorded in Book 2484, Page 234 ("Third Amendment"); and Amendment to Master Deed recorded in Book 0257, Page 955 ("Fourth Amendment"); and

WHEREAS, Riverside Horizontal Property Regime, by and through its Board of Directors, has determined that the ~~Fourth~~ Amendment was erroneously recorded in that the ~~Fourth~~ Amendment was not enacted in accordance with the requirements of Article XII, Section 1 of the Master Deed; and

WHEREAS, the Board of Directors for Riverside Horizontal Property Regime has resolved to formally and publically rescind the previously recorded ~~Fourth~~ Amendment, and further, to authorize the undersigned President and Secretary of the Association to execute the within Rescission on its behalf.

NOW, THEREFORE, Riverside Horizontal Property Regime, by and through its duly authorized officers, does hereby rescind the ~~Fourth~~ Amendment recorded in the RMC Office for Charleston County, South Carolina on June 13, 2012, in Book 0257, at Page 955.




