WHEREAS, the Ironwood Owners Association, Inc. , a South Carolina mutual benefit,

Association, Inc. ("Bylaws"), as recorded in the RMC Office for Charleston County in Book
U-366, Page ~~XXX~~ 007;

WHEREAS, the Association desired to amend the Bylaws; and

WHEREAS by a vote of its Members representing greater than fifty-one percent (51%)
of the Common Interests of the Association, the Association voted to amend Article IV,
Section 4.2.2 A. of the Bylaws as follows.

NOW THEREFORE KNOW ALL MEN BY THESE PRESENTS THAT the Bylaws
are hereby amended by deleting and adding thereto the following:

1. Article IV, Section 4.2.2 A., is amended by deletion and replacing it with the
following: "The successor Board shall consist of not less than five (5) nor more than seven (7)
Persons."
