#### to Articles of Incorporation

for

#### 377 King Street Homeowners Association, Inc.

The optional provisions, which the nonprofit corporation elects to include in the articles of incorporation are as follows (See 33-31-202(c) of the 1976 South Carollna Code of Laws, as amended, the applicable comments thereto, and the instructions to this form).

- a. Words. Any capitalized words herein shall have the same meanings attributable to them in the Master Deed for 377 King Street Horizontal Property Regime dated July 8, 2004 and recorded in the Office of the Register Mesne Conveyances for Charleston County, South Carolina on July 21, 2004 at Book U-502, at page 39.
- b. <u>Purpose</u>. This Association does not contemplate pecuniary gain or profit and the specific, primary purposes for which it is formed are to provide for the management, administration, maintenance and preservation of the 377 King Street development and the Common Areas thereof, all according to the Master Deed. No part of the net earnings of the Association shall inure to the benefit of any person, other than for acquiring, constructing or providing management, maintenance and care of Association Property and other than by a rebate of excess of Association fees, if any.
- c. Rights of Declarant. The Declarant, under the Master Deed, has extensive control and rights and the specifics and details of the same are clearly set forth in the Master Deed.
- Membership. Every Owner of a Lot is subject to the Master Deed and must be a member of the Association. The membership of each Co-Owner or Unit Owner shall be appurtenant to and may not be separated from ownership of a Unit and Ownership of a Unit shall be the sole qualification for such membership. In the event that fee title to a Unit is transferred or otherwise conveyed, the Membership in the Association, which is appurtenant thereto shall automatically pass to such transferee notwithstanding any failure of the transferor to endorse to his transferee any certificates or other evidences of such membership. Any person or entity who holds an interest in a Unit merely as security for the performance of an obligation shall not be a member of the Association.


