

STATE OF SOUTH CAROLINA) SECOND AMENDMENT TO MASTER DEED OF RADCLIFFE PLACE HORIZONTAL

COUNTY OF CHARLESTON) PROPERTY REGIME

THIS SECOND AMENDMENT to Master Deed of Radcliffe Place Horizontal Property Regime ("Second Amendment") is made by Radcliffe Place Homeowners Association, Inc., a South Carolina nonprofit corporation ("Association").

WITNESSETH:

WHEREAS, the Master Deed for Radcliffe Place Horizontal Property Regime was recorded in the RMC Office for Charleston County, South Carolina on June 21, 2002, in Book X-409, Page 188, et seq. ("Master Deed"); and

WHEREAS, the Master Deed was subsequently amended by First Amendment to Master Deed of Radcliffe Place Horizontal Regime which was recorded in the RMC Office for Charleston County, South Carolina on January 27, 2003, in Book E-434, at Page 736, et seq. ("First Amendment"); and

WHEREAS, the Bylaws for Radcliffe Place Homeowners Association, Inc. ("Bylaws") are attached as Exhibit "F" to the Master Deed; and

WHEREAS, Article XIII of the Master Deed provides, in part, that the Master Deed may be amended at the regular or any special meeting of the Association called and convened in accordance with the Bylaws, upon the affirmative vote of two-thirds (2/3) of all voting-members of the Association; and

WHEREAS, at the regular annual meeting of the Association held September 16, 2009, called and convened in accordance with the Bylaws, two-third (2/3) of all voting members in the Association approved an amendment to the Master Deed as hereinafter more specifically set forth.

NOW, THEREFORE, upon the affirmative vote of two-thirds (2/3) of all voting members in the Association, at the regular annual meeting of the Association held September 16, 2009, called and convened in accordance with the Bylaws, the Master Deed was amended as follows:

By deleting Section 5, Article II of the Bylaws, attached as Exhibit "F" to the Master Deed and substituting the following:

Section 5. Quorum. A quorum at any regular annual meeting or special meeting of the Association shall consist of those members of the Association owning twenty-five (25%) percent or more of the square footage of the Condominium Property, as a whole, as set forth in the Master Deed and



Exhibit "E" attached to such Master Deed. At any such regular annual meeting or special meeting of the Association at which such a quorum is present, the acts approved by fifty-one (51%) percent of the Members present at such meeting shall constitute the decision of the Association and shall be binding upon all members of the Association.

EXCEPT AS AMENDED HEREIN, all other terms and conditions of the Master Deed, as amended by the First Amendment, shall remain in full force and effect.
