

- Duration. The Corporation shall have perpetual duration. 2.
- Applicable Statute. The Corporation is a mutual benefit corporation organized pursuant to the provisions of the South Carolina Nonprofit Corporation Act of 1994, § 33-31-101 et seq., of the South Carolina Code of Laws, as amended (the "South Carolina Nonprofit Corporation Act of 1994").
- Purposes and Powers. The Corporation does not contemplate pecuniary gain or benefit, direct or indirect, to its members.
  - In way of explanation and not of limitation, the purposes for which it is formed are: a.
  - to be and constitute the Association to which reference is made in the Master Deed for One Belle Hall Horizontal Property Regime, as may hereinafter be amended, filed of record in the RMC Office for Charleston County, South Carolina ("Master Deed"), to perform all obligations and duties of the Association, and to exercise all rights and powers of the Association, as specified therein, in the Bylaws of the Association ("Bylaws"), and as provided by law; and
  - to provide an entity for the furtherance of the interests of the owners of units in the condominium development as described in the Master Deed.
  - In furtherance of its purposes, the Corporation shall have the following powers, which, unless indicated otherwise by the Master Deed or Bylaws, may be exercised by the Board of Directors of the Association:
    - all of the powers conferred upon nonprofit corporations by common law and the statutes of the State of South Carolina in effect from time to time; and
    - all of the powers necessary or desirable to perform the obligations and duties and to exercise the rights and powers set out in these Articles, the Bylaws, the Master Deed, or provisions § 27-31-10 et seq., of the South Carolina Code of Laws (the "South Carolina Horizontal Property Act'), including, without limitation, the following:
      - to fix and to collect assessments or other charges to be levied (A) against the units:
      - to manage, control, operate, maintain, repair, and improve the common area and facilities, and property subsequently acquired by the Corporation, or any property owned by another, for which the Corporation, by rule. regulation, Master Deed, or contract, has a right or duty to provide such services;
